TERMS & CONDITIONS

Thank you for choosing to work with Soul Bliss Journeys for your Bali Retreat. Our commitment to you is a stress free experience with a team of professionals on hand to make it a magical journey. This our promise to you. Our aim is to help you create a retreat your guests will never forget. Soul Bliss Journeys is responsible for the smooth running of your retreat in Bali. Please read through our terms and conditions below. We can't wait to create with you. Namaste.

INITIAL DEPOSIT SOUL BLISS JOURNEYS:

Once you have decided you would like to work with us we require a one time non-refundable deposit of \$1000 USD. This deposit is creditable towards the final balance of your retreat. This credit is valid for up to 24 months if your retreat is postponed. Soul Bliss Journeys works only with the leader directly and not the attendees.

YOUR GUESTS INITIAL ATTENDEE DEPOSIT: We advise that you ask for a minimum of \$500 USD deposit on sign up from each of your attendees, the deposit can be fully refundable up until 4 months before the retreat if you wish. This however is entirely up to you, as you are only required to send money to us at 4 months and 2 months before the retreat. Make sure your guests have cancellation insurance as part of their travel insurance, just in case they choose to cancel after the money has been paid and is non refundable. I advise to make insurance mandatory to join your retreat.

Please keep in mind, any payment transfer fees that you may be charged when taking payments from your guests (depending on your method of payments as Pay Pal, Stripe etc charge fees to receive money) make sure to add this into your mark up. Also take into account, that any fees you might have for transferring funds to us will be from your own account. We need the full amount quoted to reach us in Bali. Soul Bliss Journeys only deals with you directly for payments and not your guests and uses WISE payment platform. We quote in IDR currency and need to receive the IDR per person rate you will be quoted in whatever currency you are sending. Make sure when you price your retreat that you take into account currency changes, as the IDR rate you convert at the time of promoting might go up or down, so you need to keep that in mind, we will need the IDR amount when you send us payments.

In certain circumstances Soul Bliss Journeys may agree to be in charge of receiving payments from your guests if that was discussed in your discovery call. We use WISE platform for this purpose, and in this case we will need to add extra to cover fees on our end.

PLEASE NOTE: Soul Bliss Journeys wholesale rate is based on 10 paying clients or the amount of clients you have advised you will bring. If you are unable to fill 10 spots or the spots you were quoted for – your quote will be re-negotiated to a different higher rate. Please keep this in mind, as if the numbers are lower than 10, the difference to cover any costs involved with less people will fall under you, the leader/host.

OUR PAYMENT AT 4 MONTHS OUT: At this time we require 50% of the IDR per person rate you were quoted for the guests you have signed up already, hopefully all 10, and if not, then just those who have already signed up. Payments after 4 months are non refundable, so it is important at this point to make sure everything is on track to go ahead, that you have the numbers or are feeling confident that your retreat will happen. .

OUR PAYMENT AT 2 MONTHS OUT: At this time are we require the balance of the IDR per person rate (the other 50%). which is non refundable.

CANCELLATION/POSTPONING AND REFUNDS: We understand sometimes cancellations/postponements happen. Please be aware that when you book your Retreat with Soul Bliss Journeys, there are many deposits and payments made to secure your booking. Therefore, if a cancellation is made close to the date of the retreat, there will be non-refundable payments, so make sure your guests have cancellation insurance. We are not responsible for restrictions in your own country that might stop you from traveling.

6 MONTHS/180 DAYS - If you decide to cancel your retreat at this your stage initial deposit (\$1000) will be forfeited as it is non refundable. If you want to postpone the retreat, your deposit comes with you for 24 months.

4 MONTHS/120 DAYS - If a cancellation is made after the payment at 4 months, the 50% payment you have made is non refundable, again it is important at this point to make sure everything is on track to go ahead, that you have the numbers or are feeling confident that your retreat will happen. .

2 MONTHS/60 DAYS - If a cancellation is made after 2 months when full/final payment has been made, no refund will be given.

Please Note: All payments are fully creditable for 24 months towards a postponed date if the retreat is cancelled due to the shut down of Bali and you are unable to enter.
